The Central Commission for Quality Assurance and Evaluation (CCQAE) is an advisory body of the Senate. Its competencies are: to draft the guide of quality assurance assessment activities, to draft instruments for qualitative and quantitative assessment, to draft and review assessment/self-assessment reports, to review self-assessment reports for institutional and program accreditation, to review self-assessment reports for institutional and program reaccreditation in relation to the level of addressing the issues raised by KAA, to approve members of working groups for carrying out assessments as needed and to lead the process of publishing assessment reports.
